## One Year of the German Supply Chain Due Diligence Act: bizpando AG reports Success Figures and celebrates 1,000 Companies on the Platform

A big step towards more corporate responsibility, but also an immense challenge for many German companies - since the extension of the scope of application on 1 January 2024, the law applies to around 5,200 companies. Today, bizpando, the digital solution for implementing the LkSG, is celebrating reaching 1,000 companies from various industries on the platform.

bizpando is a B2B platform on which supply chain laws can be implemented in a smart and collaborative way. In 2023, bizpando has experienced strong growth: over 1,000 companies from 20 countries worldwide are now represented on the platform.
